A CPD visit to Lui Seng Chun will be held on 20 July 2019, *exclusive to HKIFM members*. Designated a Grade I historic building, Lui Seng Chun was revitalized by Hong Kong Baptist University and transformed into the HKBU School of Chinese Medicine with financial assistance from the Government. While conserving the heritage and architectural merits of the building, the project, completed in 2012, has turned Lui Seng Chun into a unique historical and cultural landmark of the city.

#### Introduction :

Lui Seng Chun is an old Chinese shophouse (*tong lau*) originally owned by a renowned businessman Mr Lui. Designed and built by architect W.H.Bourne, the building was completed in 1931. It became vacant in the 1970s after the Lui's family moved out.

In 2000, the Antiquities Advisory Board designated Lui Seng Chun a Grade I historic building. It was included in Batch I of the "Revitalising Historic Buildings Through Partnership Scheme" initiated by the Government in 2008 and Hong Kong Baptist University was selected to conserve the building and convert it into a Chinese medicine healthcare centre. The revitalization work was completed in 2012.

In terms of heritage conservation, every effort was made to retain the original architectural features as far as possible. Necessary alterations and addition works were carried out in compliance with modern buildings and fire regulations as well as meeting the operational needs of the clinic.

In the process, the University adhered to the basic principle of minimizing impact of the alterations while ensuring that all alterations could be reversed if necessary. The project, with a view to conserving the heritage and architectural merits of Lui Seng Chun, has now turned the building into a unique historical and cultural landmark.





The accumulation of  $CO_2$  in the atmosphere, due to burning of fossil fuels for electricity generation, has reached the alarm level.

The  $CO_2$  content is increasing by 2-3 ppm annually and climbed to 393 ppm (part per million) in 2011. By the end of this century, the Earth's temperature will rise by 2°C to

4°C. Low level land and islands such as the Netherlands, will be covered by water.

We need to develop renewable energy to control greenhouse gas emission and energy security. For the FMCs in coming months, we are going to share the basics of renewable energy sources, factors affecting the choices and global approaches to energy development and conservation.



### **CPD Requirements for Members**

Continuing professional development (CPD) is a common requirement of most professional institutes to ensure effective execution of professional duties throughout the members' working life. With the approval of the Council, the Institute has laid down the CPD requirements for its members.

In brief, all members (including fellows) and associates should complete a minimum of 20 hours per year on a mandatory basis starting from 1 July 2015. The CPD may come under 3 categories: (1) education and training, (2) community, institutional, and social services, (3) private study. A minimum of 10 hours should fall within the type of education and training, of which at least 4 hours should be FM related activities. Private study should be subject to a maximum claim of 5 hours per year.
